APRIL IS **FAIR HOUSING** MONTH



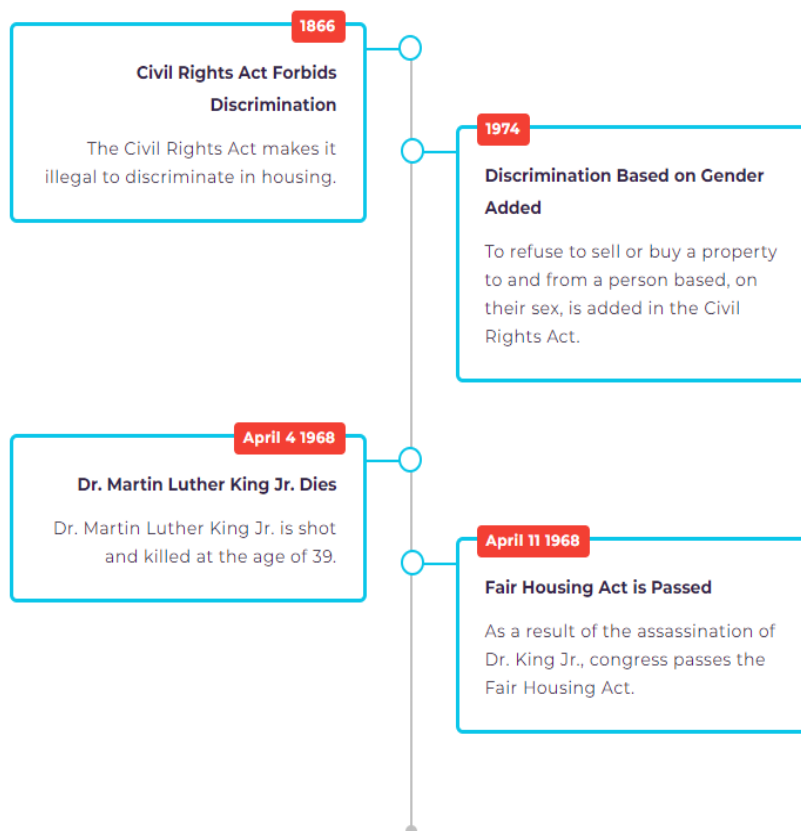
April is the month when we celebrate National Fair Housing Month. In this month we feel grateful for the Fair Housing Act that was passed on April 11, 1968. This law was designed to protect Americans from facing discrimination in selling or buying houses. It is also a basic human concept, and entitlement for people. As a community, we have the right to be free of any form of discrimination. In our communities, people belonging to diverse backgrounds should be warmly welcomed as our neighbors.

In the past, people used to show discrimination towards others in terms of housing. Some of the most damaging discrimination examples are found in the past, including minority neighborhoods that were located far from quality schools, public transportation, and jobs.

The Fair Housing Act was signed by President Johnson and it was passed after the death of civil rights leader Dr. Martin Luther King, Jr., who was in Memphis on April 4, 1968, to support the sanitation workers strike when he was shot and killed. As a result of the tragedy, Congress collectively passed the 1968 Fair Housing Act.

National Fair Housing Month is celebrated to be grateful for the Fair Housing Act which was passed in April. A law that forbids discrimination in buying houses through different schemes. These include discrimination in the rental, sale, and financing of houses based on color, race, and even gender.

In November 2021 KCEOC Community Action Partnership, Inc was awarded an ARC INSPIRE grant for the Southeast Kentucky Partnership in Restoration project. This project will provide work readiness and vocational training, job placement and career services, work based learning opportunities, and wraparound support for 60 participants of the Appalachian Restoration Project's residential and recovery program over the two year grant period.

**The project officially began enrollment on January 30, 2022.
As of April 22, 2022 the project has enrolled 30 participants.**

Those 30 participants have received the following services
within the first 3 months:

Career Services & Assessments – 30

Work based learning – 29

Enrolled into post secondary / vocational training - 26

Multiple partners will also participate in the project over the next two years. Southeast Kentucky Community and Technical College (SKCTC) will provide vocational and career training in order to prepare participants with secure, sustainable, and well-paying jobs in fields vital to local and regional economic growth. Forty local businesses will also partner to offer work-placed learning and employment opportunities for participants.

KEEP ALL MAIL FROM THE IRS!

Make sure you keep all mail from the IRS - you will need it to access benefits like the Child Tax Credit and/or the Earned Income Tax Credit in the future.



Here are some do's and don'ts for anyone who receives mail from the IRS:

- **Don't ignore it.** Most IRS letters and notices are about federal tax returns or tax accounts. Each notice deals with a specific issue and includes specific instructions on what to do.
- **Don't throw it away.** Taxpayers should keep notices or letters they receive from the IRS. These include adjustment notices when an action is taken on the taxpayer's account, Economic Impact Payment notices, and letters about advance payments of the 2021 child tax credit. They may need to refer to these when filing their 2021 tax return in 2022. In general, the IRS suggests that taxpayers keep records for three years from the date they filed the tax return.
- **Don't panic.** The IRS and its authorized private collection agencies do send letters by mail. Most of the time, all the taxpayer needs to do is read the letter carefully and take the appropriate action.
- **Don't reply unless instructed to do so.** There is usually no need for a taxpayer to reply to a notice unless specifically instructed to do so. On the other hand, taxpayers who owe should reply with a payment. IRS.gov has information about [payment options](#).
- **Do take timely action.** A notice may reference changes to a taxpayer's account, taxes owed, a payment request or a specific issue on a tax return. Acting timely could minimize additional interest and penalty charges.
- **Do review the information.** If a letter is about a changed or corrected tax return, the taxpayer should review the information and compare it with the original return. If the taxpayer agrees, they should make notes about the corrections on their personal copy of the tax return and keep it for their records.
- **Do respond to a disputed notice.** If a taxpayer doesn't agree with the IRS, they should mail a letter explaining why they dispute the notice. They should mail it to the address on the contact stub included with the notice. The taxpayer should include information and documents for the IRS to review when considering the dispute.
- **Do remember there is usually no need to call the IRS.** If a taxpayer must contact the IRS by phone, they should use the number in the upper right-hand corner of the notice. The taxpayer should have a copy of their tax return and letter when calling the agency.
- **Do avoid scams.** The IRS will never contact a taxpayer using social media or text message. The first contact from the IRS usually comes in the mail. Taxpayers who are unsure if they owe money to the IRS can view their tax account information on IRS.gov.

Homeowner Assistance Fund

OVERVIEW

The Team Kentucky Homeowner Assistance Fund keeps Kentucky homeowners safe and healthy in their homes and protects them from foreclosure due to delinquent mortgage, tax, insurance and utility payments and homeowner's association fees due to financial distress caused by COVID-19.

PROGRAM DESCRIPTION

Kentucky received \$85.4 million in federal American Rescue Plan Act Funds to help prevent foreclosure for homeowners who have been impacted economically by COVID-19. After working with the U.S. Treasury for six months, Kentucky Housing Corporation (KHC) the agency administering these federal funds, received approval for its program plan in late December.

Qualifying homeowners may receive up to \$35,000 in assistance to repay delinquent mortgage bills, utility payments, insurance premiums, property taxes and homeowner's association fees. Payments will be made directly to the agencies owed.

DETAILS

- The Homeowner Assistance Fund portal will open at 8 a.m. Monday, February 7, 2022.
- Funds will be available until fully expended or September 30, 2025, whichever comes first.
- Homeowners must meet certain income guidelines. An income calculator is available at <https://teamkyhaf.ky.gov>.
- Applicants must be living in the home, and were living in it during the pandemic hardship, for which they are applying for assistance.
- To qualify, homeowners must work with a participating HAF housing counselor, who will walk them through the process.
- Homeowners must provide verification of income and an assessment of their home and property.
- All documents will be electronically signed.
- The date of the qualifying hardship has to have occurred on or after January 21, 2020.
- Lump sum, direct payments will be made to the services, utility companies, insurance companies, county tax administrators and homeowner's associations.

SLIDE BULLETS

- Starting February 7, 2022, Kentucky will launch the Homeowner Assistance Fund, a statewide effort to prevent foreclosures.
- Not all homeowners will qualify. They must meet income requirements as well as produce certain documents showing their financial distress from COVID.
- Assistance is available for delinquent mortgage payments, utility bills, insurance premiums, property taxes and homeowner's association fees.
- Utilities include electric, water, sewer and gas. Qualifying homeowners must be at least 90 days past due to receive utility assistance.
- Approved homeowners may receive up to \$35,000 in assistance. Homeowners may only receive assistance one time.
- Payments will be made directly to the entities owed – mortgage servicers, utility companies, etc.
- Each applicant will work with a housing counselor, who will guide them through the process.

The Team Kentucky Homeowner
Assistance Fund will pay:

- Mortgage payments (up to 6 months of past due payments)
- Mortgage-related expenses
- Liens
- Homeowner's association fees, condominium association fees
- Property taxes
- Insurance
- Utilities (must be at least 90 days past due)

To qualify, homeowners must:

- Sign a document explaining their COVID hardship
 - Loss of income*
 - Increase in expenses*
- Have an income less than 150% of the area median income

Payments will be made:

- Up to \$35,000 per household
- Directly to those owed
 - Servicers
 - HOAs
 - Insurance companies
 - Tax assessors
 - Utility providers (electric, gas, water, sewer)

*The threshold for qualification is a hardship of 15% or greater - 15% or greater reduction in income or 15% or greater increase in household expenses. Applying for assistance and signing the affidavit of hardship is not a guarantee of approval for HOAF funds.

KCEOC CAP is now accepting applications for the new Low Income Home Water Assistance Program (LIHWAP) Crisis Component. Applications will be accepted through June 1, 2022, or until designated funds are depleted on a first-come, first-serve basis.

The Crisis Component can assist households, up to and including 150 percent of the federal poverty guidelines, who are experiencing a water and/or wastewater crisis. Applicants must provide at least one of the following: a disconnect/past due notice, disconnection notice, or an eviction notice for non-payment of rent (if water service cost is included in your rent). Benefits are paid directly to household's water service vendor.

Benefits offered through the Crisis component are limited to the minimum to alleviate the crisis **not** to exceed \$800. Households can reapply each time they experience a crisis until they have reached their maximum benefits.

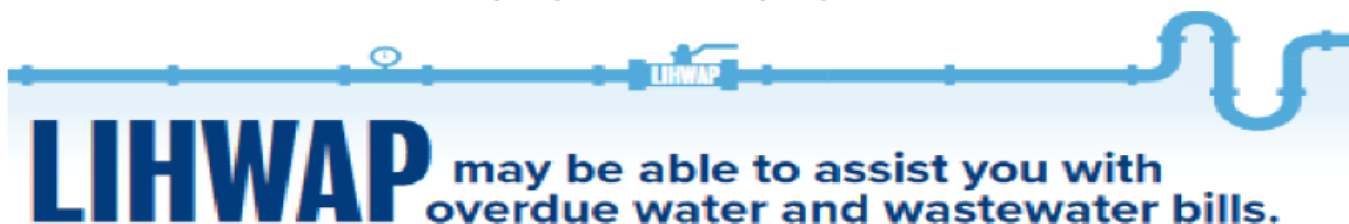
All applicants will be required to supply the following documentation at the time of application:

- Proof of Social Security Number or Permanent Residence card (Green Card) for each member of the household.
- Proof of all household's (all members) income from the preceding month.

Most current water service bill (water and/or wastewater), including account number and name on account, statement from your landlord if water service expenses are included in your rent, statement from utility company if you participate in a Pre-Pay Program.

LIHWAP Subsidy Component enrollment period begins January 10, 2022. Eligible households can apply for a one-time water service benefit ranging from \$300 to \$400 depending on income level, housing category, and water service benefit type. Participation in LIHWAP Crisis will not affect a household's eligibility. Households must meet eligibility requirements, including income guidelines.

KCEOC Community Action Partnership now has funding available for Homeless Prevention Services. Households must live in Bell, Harlan, Knox, or Whitley Co. Households must also be below 50% of area median income, & must not have sufficient resources or support networks immediately available to prevent them from moving to an emergency shelter or other location.

Applicants must meet one of the following “At-Risk” Factors:

- Has moved because of economic reasons two or more times during the 60 days immediately preceding the application for homelessness prevention assistance;
- Is living in the home of another because of economic hardship;
- Has been notified in writing that their right to occupy their current housing or living situation will be terminated within 21 days after the date of application for assistance;
- Lives in a hotel or motel and the cost of the hotel or motel stay is not paid by charitable organizations or by federal, State, or local government programs for low-income individuals;
- Lives in a single-room occupancy or efficiency apartment unit in which there reside more than two persons or lives in a larger housing unit in which there reside more than 1.5 people per room, as defined by the U.S. Census Bureau;
- Is exiting a publicly funded institution, or system of care (such as health-care facility, mental health care facility, foster care or other youth facility, or correction program or institution); or
- Otherwise lives in housing that has characteristics associated with instability and an increased risk of homelessness, as identified in the recipient’s approved consolidated plan

ends homelessness for
families and individuals.

RRH HELPS

Rapid Re-Housing (RRH) is a set of strategies developed in coordination with an individual or family, to help them quickly move out of homelessness and into permanent housing. It is offered without preconditions (e.g., employment, income, absence of criminal record, or sobriety) and the resources and services provided are typically tailored to the unique needs of the household.

KCEOC Community Action Partnership will accept individuals and families into the ESG Rapid Re-Housing program who fall under HUD guidelines for homelessness and meet ESG criteria for services; participation in the RRH program is voluntary.

RRH does not have service participation requirements or preconditions to entry, the program is extremely low-barrier for those wishing to participate.

The **only** requirements for the program are:

- Participants must fall under HUD's Category 1 (street/shelter homeless) definition
- **(OR)** Participants must fall under HUD's Category 4 (domestic violence) definition for homelessness to be eligible for assistance.
