KCEOC Community Action Partnership was recently selected as one of the 2022 Best Nonprofits to Work For. The NonProfit Times, the leading national business publication for nonprofit managers, has partnered with Best Companies Group to identify nonprofit organizations where leaders have excelled in creating quality workplaces.

This survey and awards program is designed to identify, recognize and honor the best employers in the nonprofit industry, benefiting the industry's economy, workforce and businesses. The list is made up of only 50 non-profit organizations nationwide.

Nonprofits from across the United States entered the two-part survey process to determine *Best Nonprofits to Work For*. The first part consisted of evaluating each nominated organization's workplace policies, practices, philosophy, systems and demographics. This part of the process was worth approximately 25% of the total evaluation.

The second part consisted of an employee survey to measure the employee experience. This part of the process was worth approximately 75% of the total evaluation. The combined scores determined the top nonprofits and the final ranking. Best Companies Group managed the overall registration and survey process, analyzed the data and determined the ranking.

Homeless Americans also qualify for an Economic Impact Payment. If they normally don't file taxes, they need to sign up at IRS.gov.

#### Tax Tips for People Experiencing Homelessness:

Filing taxes can be a complicated process, especially if you are experiencing housing instability or homelessness. If you have lost your tax documents, don't know where to file your taxes, or don't know how to receive your refund, here are some guidelines to help prepare you to file your taxes.

#### Should I file taxes if I don't have to?

Even if you aren't required to file a tax return, you may still qualify for tax credits like the Earned Income Tax Credit (EITC) and the Child Tax Credit. These credits reduce the amount of taxes you owe and may provide a refund at tax time. To claim the credits, all you need to do is file your taxes.

#### How do I file taxes without a permanent address?

Shelters and other service providers, such as health care clinics and drop-in day centers, may allow you to use their address for tax purposes. Other agencies that offer homeless prevention services like a Community Action Agency or Salvation Army are also options. If you are not staying in a shelter or cannot find a service provider nearby, you can also use a relative's or friend's address.

## Tax Tips for People Experiencing Homelessness Continued:

#### How do I file taxes if I've lost my tax forms?

To file taxes, you will need Forms W-2 or 1099, provided by your employer. If you did not receive these forms or misplaced them, you can still file taxes and claim tax credits by obtaining a copy of these documents from your employer.

If you cannot get a copy, you can fill out Form 4852, Substitute for Form W-2, Wage and Tax Statement, or Form 1099-R, Distributions From Pensions, Annuities, Retirement or Profit-Sharing Plans, IRAs, Insurance Contracts, etc. These forms will request information about your wages and taxes that are withheld, so it would be helpful if you have documentation, such as a final pay stub, to complete it. If you do not have a final pay stub, you may still be able to fill out the form by estimating your earnings.

If you are unable to estimate your earnings, you can request a wage and income transcript from the IRS for free. This transcript includes data for Forms W-2, 1099, and 1098.

You have two options to receive the transcript.

Online: Register for Get Online Transcript, to instantly view, print, or download your transcript. Online transcripts are redacted and mask some of your personal information to help reduce identity theft.

To use Get Online Transcript, you will need to sign in with your existing IRS username or create a new account with ID me. To create a new account, you will need to have photo identification, such as a driver's license, state ID, or passport. You will also need to take a selfie with a smart phone or a computer with a webcam.

**Mail:** Use Get Transcript by Mail or call the automated phone transcript service at 800-908 -9946 to get your transcript by mail. You will need your mailing address from your most recent tax return. The IRS will mail un-redacted transcripts with all your personal information visible to the last address they have on record for you. It will take 5 to 10 calendar days from the time the IRS receives your request.

If your address has changed from the one used on your most recent tax return, you will need to file Form 8822, Change of Address, to update your mailing address to the one you will use to file your tax return before requesting a transcript by mail. Transcripts cannot be faxed.

If neither of those options work, you can submit Form 4506-T, Request for Transcript of Tax Return, to get tax return information.

If your state requires you to file a state return, contact your state's department of revenue or tax office to get info on any state tax withheld.

#### Where do I find free tax help?

If you (and your spouse if filing jointly) earn less than \$57,000, you could qualify for free tax preparation in your community. Volunteer Income Tax Assistance (VITA) and AARP Tax-Aide sites offer free and reliable tax filing services. To find a site, visit the IRS' site locator tool.

## KCEOC Community Action Partnership Awarded Kentucky Association of Health Plan's "Healthy Together through Vaccinations" Community Grant.

KAHP's initiative that aims to mobilize and empower organizations throughout the Commonwealth to help address vaccine hesitancy and increase vaccinations.



Lexington, Ky. (Dec. 20, 2021) – Kentucky Association of Health Plans (KAHP), the trade association representing all carriers offering health coverage in Kentucky, today announced 27 grant award winners for the organization's "Healthy Together Through Vaccinations" community grant program. The initiative aims to increase COVID-19 vaccine acceptance and

access by empowering organizations across KY with grants of up to \$25,000 to pursue efforts toward improving vaccination rates through outreach, communication, education, training, transportation, and/or support. "For many months now, we have been partnering with various groups across the Commonwealth and have had a lot of success in our vaccination efforts," said Tom Stephens, executive director of KAHP. "We applied some of what we learned in that programming to launch a broader grant initiative that we think is quite impactful because we are really leveraging local organizations who know their communities best. It's great to see so many different populations served. We certainly aren't letting up because vaccines are the best defense against hospitalization and death."



"KCEOC CAP's President/CEO Paul Dole stated, "When you work in community action, you have to be prepared to serve on the front lines no matter what- we won't ever stop serving our community, and we certainly didn't let the Covid-19 pandemic stop us although we had to pivot and re-pivot our service delivery many times to ensure our clients and staff remained safe. When Covid-19 hit, we were quick to action, and have remained constant in our response,

because we knew it was affecting our clients disproportionately. The entire team at KCEOC is dedicated to eradicating poverty in all of its forms, we stand by our Community Action Promise to help others help themselves and each other, and we accomplish this by removing barriers. We are grateful for this grant so that we can begin our "Healthy Together Initiative" to continue removing barriers, our clients that want to receive the vaccine are facing, we will be addressing lack of access and availability in remote areas, transportation barriers, and sharing fact-based information."

## Homeowner Assistance Fund

#### **OVERVIEW**

The Team Kentucky Homeowner Assistance Fund keeps Kentucky homeowners safe and healthy in their homes and protects them from foreclosure due to delinquent mortgage, tax, insurance and utility payments and homeowner's association fees due to financial distress caused by COVID-19.

#### PROGRAM DESCRIPTION

Kentucky received \$85.4 million in federal American Rescue Plan Act Funds to help prevent foreclosure for homeowners who have been impacted economically by COVID-19. After working with the U.S. Treasury for six months, Kentucky Housing Corporation (KHC) the agency administering these federal funds, received approval for its program plan in late December.

Qualifying homeowners may receive up to \$35,000 in assistance to repay delinquent mortgage bills, utility payments, insurance premiums, property taxes and homeowner's association fees. Payments will be made directly to the agencies owed.

#### DETAILS

- The Homeowner Assistance Fund portal will open at 8 a.m. Monday, February 7, 2022.
- Funds will be available until fully expended or September 30, 2025, whichever comes first.
- Homeowners must meet certain income guidelines. An income calculator is available at https://teamkyhaf.ky.gov.
- Applicants must be living in the home, and were living in it during the pandemic hardship, for which they are applying for assistance.
- To qualify, homeowners must work with a participating HAF housing counselor, who will walk them through the process.
- Homeowners must provide verification of income and an assessment of their home and property.
- All documents will be electronically signed.
- The date of the qualifying hardship has to have occurred on or after January 21, 2020.
- Lump sum, direct payments will be made to the services, utility companies, insurance companies, county tax administrators and homeowner's associations.

#### SLIDE BULLETS

- Starting February 7, 2022, Kentucky will launch the Homeowner Assistance Fund, a statewide effort to prevent foreclosures.
- Not all homeowners will qualify. They must meet income requirements as well as produce certain documents showing their financial distress from COVID.
- Assistance is available for delinquent mortgage payments, utility bills, insurance premiums, property taxes and homeowner's association fees.
- Utilities include electric, water, sewer and gas. Qualifying homeowners must be at least 90 days past due to receive utility assistance.
- Approved homeowners may receive up to \$35,000 in assistance. Homeowners may only receive assistance one time.
- Payments will be made directly to the entities owed mortgage servicers, utility companies, etc.
- Each applicant will work with a housing counselor, who will guide them through the process.

The Team Kentucky Homeowner Assistance Fund will pay:

- Mortgage payments (up to 6 months of past due payments)
- · Mortgage-related expenses
- Liens
- Homeowner's association fees, condominium association fees
- · Property taxes
- Insurance
- Utilities (must be at least 90 days past due)

To qualify, homeowners must:

- Sign a document explaining their COVID hardship
  - · Loss of income\*
  - Increase in expenses\*
- Have an income less that 150% of the area median income

Payments will be made:

- Up to \$35,000 per household
- · Directly to those owed
  - Servicers
  - · HOAs
  - Insurance companies
  - Tax assessors
  - Utility providers (electric, gas, water, sewer)

\*The threshold for qualification is a hardship of 15% or greater - 15% or greater reduction in income or 15% or greater increase in household expenses. Applying for assistance and signing the affidavit of hardship is not a guarantee of approval for HOAF funds.

The Child Tax Credit is a fully refundable tax credit for families with qualifying children. The American Rescue Plan expanded the Child Tax Credit for 2021 to get more help to more families. The credit increased from \$2,000 per child in 2020 to \$3,600 in 2021 for each child under age 6. Similarly, for each child age 6 to 16, it's increased from \$2,000 to \$3,000. It also provides the \$3,000 credit for 17 year-olds. Under the American Rescue Plan, the IRS disbursed half of the 2021 Child Tax Credit in monthly payments during the second half of 2021.

The advance Child Tax Credit payments disbursed by the IRS from July through December of 2021 were early payments from the IRS of 50 percent of the amount of the Child Tax Credit that the IRS estimated you may properly claim on your 2021 tax return during the 2022 tax filing season.

You don't need to have income or a permanent address to claim this tax credit if you're eligible.



**KCEOC CAP** is now accepting applications for the new Low Income Home Water Assistance Program (LIHWAP) Crisis Component. Applications will be accepted through June 1, 2022, or until designated funds are depleted on a first-come, first-serve basis.

The Crisis Component can assist households, up to and including 150 percent of the federal poverty guidelines, who are experiencing a water and/or wastewater crisis. Applicants must provide at least one of the following: a disconnect/past due notice, disconnection notice, or an eviction notice for non-payment of rent (if water service cost is included in your rent). Benefits are paid directly to household's water service vendor.

Benefits offered through the Crisis component are limited to the minimum to alleviate the crisis **not** to exceed \$800. Households can reapply each time they experience a crisis until they have reached their maximum benefits.

All applicants will be required to supply the following documentation at the time of application:

- Proof of Social Security Number or Permanent Residence card (Green Card) for each member of the household.
- Proof of all household's (all members) income from the preceding month.

Most current water service bill (water and/or wastewater), including account number and name on account, statement from your landlord if water service expenses are included in your rent, statement from utility company if you participate in a Pre-Pay Program.

LIHWAP Subsidy Component enrollment period begins January 10, 2022. Eligible households can apply for a one-time water service benefit ranging from \$300 to \$400 depending on income level, housing category, and water service benefit type. Participation in LIHWAP Crisis will not affect a household's eligibility. Households must meet eligibility requirements, including income guidelines.



KCEOC reminds you to stay safe because you're essential!



KCEOC Community Action Partnership now has funding available for Homeless Prevention Services. Households must live in Bell, Harlan, Knox, or Whitley Co. Households must also be below 50% of area median income, & must not have sufficient resources or support networks immediately available to prevent them from moving to an emergency shelter or other location.

#### Applicants must meet one of the following "At-Risk" Factors:

- Has moved because of economic reasons two or more times during the 60 days immediately
  preceding the application for homelessness prevention assistance;
- Is living in the home of another because of economic hardship;
- Has been notified in writing that their right to occupy their current housing or living situation will be terminated within 21 days after the date of application for assistance;
- Lives in a hotel or motel and the cost of the hotel or motel stay is not paid by charitable organizations or by federal, State, or local government programs for low-income individuals;
- Lives in a single-room occupancy or efficiency apartment unit in which there reside more than two persons or lives in a larger housing unit in which there reside more than 1.5 people per room, as defined by the U.S. Census Bureau;
- Is exiting a publicly funded institution, or system of care (such as health-care facility, mental health care facility, foster care or other youth facility, or correction program or institution); or
- Otherwise lives in housing that has characteristics associated with instability and an increased risk of homelessness, as identified in the recipient's approved consolidated plan


