### The Benefits of a Weatherized Home









- Weatherization returns \$2.78 in health & safety related benefits for every \$1 invested.
- After Weatherization, families' out-of-pocket medical expenses decreased by an average of \$514 annually.
- Reducing energy costs means families have more money to spend on food, medicine & other essentials.
- Weatherization mitigates asthma triggers like mold. Residents of weatherized homes report fewer asthma symptoms and hospitalizations after receiving services.
- Children missed fewer school days after their homes received Weatherization services.
- In addition to weatherization services, many local weatherization agencies mitigate slip/trip/fall hazards, and other known potential hazards such as lead, carbon monoxide, and fire prevention/safety.







### The History of the Weatherization Assistance Program

October marks the 45th anniversary of the Department of Energy's Weatherization Assistance Program, which provides funding to states, territories, and tribal governments to improve the energy efficiency of the homes of low-income families, persons with disabilities, and senior citizens. The Weatherization Assistance Program has successfully weatherized more than 7 million American homes to date.

The program was born out of the 1973 oil crisis, when unemployment and energy prices were exceptionally high. Energy conservation measures emerged as one of the nation's top priorities. In 1976, Congress passed the Energy Conservation Policy Act and the Weatherization Assistance Program was born.

The first decade saw weatherization crews focus on fundamentals of air sealing: installing cellulose insulation and caulking, but as the program expanded its services in the 1980s and 1990s, so did understanding of the treating the building as an entire system. New testing technologies such as infrared cameras and blower doors allowed auditors to see into homes in a new and more intricate way.

Weatherization technicians recognized that a building's shell, appliances, and occupants all affected the safety and comfort of a home. This concept became known as the "whole-house" approach, and weatherization and home performance technicians use this approach today to ensure that all parts of the home work together to maximize efficiency, comfort, and health.

The Weatherization Assistance Program has evolved to become one of the most successful programs in the federal government concerning advancing an energy efficient economy. The program performs energy audits on each home to determine which measures are most cost-effective, and every dollar spent on weatherization improvements can return \$1.53 in energy savings over the life of the measures.

KCEOC's Weatherization Assistance Program provides assistance to 12 counties in KY. The program was created to reduce energy waste, lower utility costs and assure the health and safety of low income residents. The Weatherization Assistance Program is funded, in part, under contract with Kentucky Housing Corporation with funds from the U.S. Department of Energy and the U.S. Department of Health and Human Services. Eligibility for WAP is based on household income up to 200% of the current Poverty Income Guidelines. Applications are assigned a point value. Priority points are given to elderly, disabled applicants and households with small children. Applicants are served in order from highest to lowest priority points. Required documents to apply for assistance are proof of current income, copies of social security cards for all household members, copy of deed/mobile home title and prior 12 months utility consumption history.

### 2022-2023 LIHEAP Fall Subsidy Program

KCEOC CAP Inc. is now accepting applications for the new Low Income Home Energy Assistance Program (LIHEAP) Fall Subsidy Component. Applications will be accepted from Nov 7th through Dec 16, 2022 or until designated funds are depleted on a first-come, first-serve basis.

The program is designed to help offset the cost of a household's heating expense.

Income eligibility for the program is up to and including 130% of the Federal Poverty Guidelines.

Benefits are paid directly to the heating vendor.

The Fall Subsidy Component provides households one-time benefit ranging from \$34 to \$206 depending on income levels, housing category, and heating fuel type.

All applicants will be required to supply the following documentation at the time of application:

### Basic Eligibility Requirements:

All applicants will be required to supply the following documentation at the time of application:

- Proof of Social Security Number or Permanent Residence card (Green Card) for each member of the household.
- Proof of all household's (all members) income from the preceding month.
- Most current utility service bill including account number and name on account statement from your landlord if utility service expenses are included in your rent statement from utility company if you participate in a Pre-Pay Program.

### THE HISTORY OF HEAD START

In 1964, the Federal Government asked a panel of child development experts to draw up a program to help communities meet the needs of disadvantaged preschool children. The panel report became the blueprint for Project Head Start. Project Head Start, launched as an eight-week summer program by the Office of Economic Opportunity in 1965, and was designed to help break the cycle of poverty by providing preschool children of low-income families with a comprehensive program to meet their emotional, social, health, nutritional, and psychological needs. Recruiting children age three to school entry age, Head Start was enthusiastically received by education, child development specialists, community leaders, and parents across the Nation. Head Start serves children and their families each year in urban and rural areas in all 50 States, the District of Columbia, Puerto Rico, and the U.S. Territories, including many American Indians and migrant children.

In 1969, Head Start was transferred from the Office of Economic Opportunity to the Office of Child Development in the U.S. Department of Health, Education and Welfare, and has now become the Office of Head Start, within the Administration on Children and Families in the U.S. Department of Health and Human Services.

Although Head Start is thought to be one program by much of the public, Head Start actually consists of two programs: Head Start and Early Head Start. Head Start is a comprehensive early childhood development program primarily serving low-income preschool-age children and their families while Early Head Start was established during the 1994 Reauthorization of Head Start. Early Head Start is a comprehensive early childhood program serving primarily low-income children prenatal to age 3, pregnant women, and their families.

# October is Domestic Violence Awareness & Prevention Month

Domestic violence is prevalent in every community, and affects all people regardless of age, socio-economic status, sexual orientation, gender, race, religion, or nationality.

# Over 10 million adults experience domestic violence annually in the U.S., including physical, sexual, verbal, emotional, and economic abuse. Domestic violence accounts for 15% of all violent crime nationwide and domestic abuse hotlines receive approximately 19,000 calls

per day.

### STOP DOMESTIC VIOLENCE



Perpetrators commit acts of domestic violence against certain survivor populations at disproportionately high rates, including women, people of color, American Indian and Alaska Native (AAIN) women, trans individuals, people living with disabilities, and people experiencing low incomes - rates are even higher among individuals that identify as being in more than one of these groups. Children are also disproportionately affected, either by being subjected to or witnessing domestic violence, which can have traumatic, long-term negative effects, including serious health conditions, anxiety, and depression. Patterns of domestic violence also lead to lower-incomes among survivors due to trauma, job loss, lack of affordable housing, and the cost of legal services. Programs and services that prevent and respond to patterns of domestic violence are crucial to addressing the causes and conditions of poverty. Community Action Agencies (CAA) provide services that directly support survivors, including crisis counseling and intervention, support groups, housing assistance, and legal referrals. But all programs that increase opportunity and economic security for people experiencing low incomes empower them with options and help prevent physical, psychological, and economic abuse. As trusted messengers in their communities, CAAs can also raise awareness about domestic violence and educate community members about advocacy actions that will reduce violence and abuse.

The Team Kentucky Homeowner Assistance Fund will pay:

- Mortgage payments (up to 6 months of past due payments)
- Mortgage-related expenses
- Liens
- Homeowner's association fees, condominium association fees
- · Property taxes
- Insurance
- Utilities (must be at least 90 days past due)

To qualify, homeowners must:

- Sign a document explaining their COVID hardship
  - Loss of income\*
  - Increase in expenses\*
- Have an income less that 150% of the area median income

Payments will be made:

- Up to \$35,000 per household
- · Directly to those owed
  - Servicers
  - HOAs
  - Insurance companies
  - Tax assessors
  - Utility providers (electric, gas, water, sewer)

\*The threshold for qualification is a hardship of 15% or greater - 15% or greater reduction in income or 15% or greater increase in household expenses. Applying for assistance and signing the affidavit of hardship is not a quarantee of approval for HOAE funds.

### **OVERVIEW**

The Team Kentucky Homeowner Assistance Fund keeps Kentucky homeowners safe and healthy in their homes and protects them from foreclosure due to delinquent mortgage, tax, insurance and utility payments and homeowner's association fees due to financial distress caused by COVID-19.

### PROGRAM DESCRIPTION

Kentucky received \$85.4 million in federal American Rescue Plan Act Funds to help prevent foreclosure for homeowners who have been impacted economically by COVID-19. After working with the U.S. Treasury for six months, Kentucky Housing Corporation (KHC) the agency administering these federal funds, received approval for its program plan in late December.

Qualifying homeowners may receive up to \$35,000 in assistance to repay delinquent mortgage bills, utility payments, insurance premiums, property taxes and homeowner's association fees. Payments will be made directly to the agencies owed.

### **DETAILS**

- The Homeowner Assistance Fund portal will open at 8 a.m. Monday, February 7, 2022.
- Funds will be available until fully expended or September 30, 2025, whichever comes first.
- Homeowners must meet certain income guidelines. An income calculator is available at https://teamkyhaf.ky.gov.
- Applicants must be living in the home, and were living in it during the pandemic hardship, for which they are applying for assistance.
- To qualify, homeowners must work with a participating HAF housing counselor, who will walk them through the process.
- Homeowners must provide verification of income and an assessment of their home and property.
- All documents will be electronically signed.
- The date of the qualifying hardship has to have occurred on or after January 21, 2020.
- Lump sum, direct payments will be made to the services, utility companies, insurance companies, county tax administrators and homeowner's associations.

### SLIDE BULLETS

- Starting February 7, 2022, Kentucky will launch the Homeowner Assistance Fund, a statewide effort to prevent foreclosures.
- Not all homeowners will qualify. They must meet income requirements as well as produce certain documents showing their financial distress from COVID.
- Assistance is available for delinquent mortgage payments, utility bills, insurance premiums, property taxes and homeowner's association fees.
- Utilities include electric, water, sewer and gas. Qualifying homeowners must be at least 90 days past due to receive utility assistance.
- Approved homeowners may receive up to \$35,000 in assistance. Homeowners may only receive assistance one time.
- Payments will be made directly to the entities owed mortgage servicers, utility companies, etc.
- Each applicant will work with a housing counselor, who will guide them through the process.

KCEOC Community Action Partnership now has funding available for Homeless Prevention Services. Households must live in Bell, Harlan, Knox, or Whitley Co. Households must also be below 50% of area median income, & must not have sufficient resources or support networks immediately available to prevent them from moving to an emergency shelter or other location.

### Applicants must meet one of the following "At-Risk" Factors:

- Has moved because of economic reasons two or more times during the 60 days immediately
  preceding the application for homelessness prevention assistance;
- Is living in the home of another because of economic hardship;
- Has been notified in writing that their right to occupy their current housing or living situation will be terminated within 21 days after the date of application for assistance;
- Lives in a hotel or motel and the cost of the hotel or motel stay is not paid by charitable organizations or by federal, State, or local government programs for low-income individuals;
- Lives in a single-room occupancy or efficiency apartment unit in which there reside more than two persons or lives in a larger housing unit in which there reside more than 1.5 people per room, as defined by the U.S. Census Bureau;
- Is exiting a publicly funded institution, or system of care (such as health-care facility, mental health care facility, foster care or other youth facility, or correction program or institution); or
- Otherwise lives in housing that has characteristics associated with instability and an increased risk of homelessness, as identified in the recipient's approved consolidated plan

# RRH HELPS

Rapid Re-Housing (RRH) is a set of strategies developed in coordination with an individual or family, to help them quickly move out of homelessness and into permanent housing. It is offered without preconditions (e.g., employment, income, absence of criminal record, or sobriety) and the resources and services provided are typically tailored to the unique needs of the household.

KCEOC Community Action Partnership will accept individuals and families into the ESG Rapid Re-Housing program who fall under HUD guidelines for homelessness and meet ESG criteria for services; participation in the RRH program is voluntary.

RRH does not have service participation requirements or preconditions to entry, the program is extremely low-barrier for those wishing to participate.

The **only** requirements for the program are:

- Participants must fall under HUD's Category 1 (street/shelter homeless) definition
- (OR) Participants must fall under HUD's Category 4 (domestic violence) definition for homelessness to be eligible for assistance.


