April is Fair Housing Month! On April 11, 1968 President Lyndon B. Johnson signed the Civil Rights Act of 1968; Title VII of that law is known as the Fair Housing Act, as amended, prohibits discrimination in the sale, rental, and financing of housing because of race, color, religion, national origin, sex, disability and family status.

The Fair Housing Act protects people from discrimination when they are renting or buying a home, getting a mortgage, seeking housing assistance, or engaging in other housing related activities.

The Fair Housing Act Covers most housing in very limited circumstances, the Act exempts owner occupied buildings with no more than four units, single-family houses sold or rented by the own without the use of an agent, and housing operated by religious organizations and private clubs that limit occupant to members..

# 2020 LIHEAP Spring Subsidy Program

In response to the COVID-19 emergency, KCEOC Community Action Partnership (CAP) is now taking applications for an added spring open enrollment period for Low-Income Home Energy Assistance Program (LIHEAP). Applications will be accepted through June 30, 2020, or until designated funds are depleted on a first-come, first-serve basis. The program, which is designed to help low-income households offset home energy costs, has increased income eligibility requirements to 150 percent of the Federal Poverty Guidelines. The benefit amount awarded is based on an individual's income and primary fuel type. Benefits are paid directly to the primary fuel vendor in the form of a voucher.

All applicants will be required to supply the following documentation at time of application:

- Proof of Social Security Number or Permanent Residence card (Green Card) for each member of the household.
- Proof of all household's (all members) income from the preceding month.
- Most current heating bill, statement from your landlord if heating expenses are included in your rent, statement from utility company if you participate in a Pre-Pay Electric Program.
- The account number and name on the account for main heating fuel sources and electric bill.

# Glenn Mason- KY Career Center Jobsight



In 2016 Glenn Mason, a professional truck driver, began having difficulties with his ear and hearing, the difficulties progressed making it necessary to consult an ENT specialist, it was there he discovered the trouble was being caused by a tumor that would require surgery. What was supposed to be a 45 minute procedure turned into an invasive four hour surgery, as the doctor found more damage than anticipated. Glenn's ear drum, incus and malleus bones, all had to be rebuilt, and doing so caused hearing loss more severe than he had previously experienced.

Glenn went on to suffer with severe post-op complications, which would turn out to be life changing. He lost the ability to walk for four weeks; he lost all ability to perform normal daily activities independently he required his wife's assistance for nearly all taskseven riding in a car was unbear-

able. The plan was to return to work a week after surgery, but Glenn soon received devastating news, the complications had left him unable to pass the DOT physical thus making him unable to continue his career as a truck driver. This was the beginning of a did, but knew he had to try, he downward spiral, Glenn soon became severely depressed. He had been the sole provider but now he had to rely on the help of his family just to put food on the table. "I couldn't provide for my family any- he was paired with Career Advisor more. I felt like such a failure at this point. I went from making decent money to absolutely nothing. We were about to lose our cars. we were about to lose everything," said Glenn, "We sold one car to help our situation, and avoid repossession; but that only made it harder on my wife."

vet either, because she was his round-the-clock caretaker for two months, and now they had limited transportation. Glenn said, "I knew I had to do something. I signed up on SNAP benefits, even though that was very hard for me. I never thought I would need to. but I had no other choice, I was always the one people came to for help, but now I was depend on the help of others, it was a terrible feeling- my pride was hurt, but I was determined to not give up."

Glenn was urged to sign up on disability, but he thought that was too much like throwing in the

towel, he was still young and had hope this disability would be temporary. Glenn was referred to the **KCEOC Community Action Part**nership KY Career Center Jobsight by the local unemployment office. He was unsure of what the agency was running out of options and realized he could not do it all on his own. During his visit with the **KCEOC Community Action Part**nership KY Career Center Jobsight **Jacqueline Pillay, who helped him** enroll in the Community Impact program, which is for individuals who have been laid off and are receiving unemployment benefits. The program provides assistance for participants to complete a two year certificate or degree.

According to Jacqueline, "When His wife could not go back to work Glenn came to the Career Center with his wife and two children he was very nervous and unsure. He was very down and he was leery about going back to school at his age, but I knew that Glenn would be able to succeed from the moment I met him. He had the motivation, he just needed the confidence. There were many people telling him just to get a job, but he knew he wanted more than just a job- he knew he wanted to be a respiratory therapist."

# Glenn Mason- KY Career Center Jobsight

When Glenn was approved for the highly competitive respiratory therapy program, he was in disbelief yet ecstatic. "Going back to school at my age was worrisome. I knew I was going to be the oldest person in my classes, but I did it anyway, and I loved it! I knew I was doing something for my family to better their lives." Glenn was able to do just that, he excelled in his classes and his clinical practicum at Southeast Kentucky Community and Technical College in Pineville, KY. He received recommendations by many of his professors, and graduated with a 3.7 GPA, he even passed the board exam on his first try. He Jacqueline. She helped me received the Academic Excellence Award, Outstanding Clinical Performance Award, two Work Ethic awards, and the HOSA Future **Health Professionals participation** award, and an invitation to the national HOSA conference in Dallas, TX. But he states his biggest accomplishment is that he was the first one in his family to go to college, and has been able to set a good example for his two children.

Soon after graduation he received an offer for a respiratory therapist position at Saint Joseph Hospital in London, KY. "My job makes me feel happy and I'm excited to go to work, best of all I am now back on my feet and am self-sufficient. People always ask why I am smiling at work, and I say when you have had everything taken away

from you, and you get it back again there is no reason not to smile!"

"When driving the truck I was making good money, now I make just as much, but I get to spend more time at home with my family and that is what is most important to me. I am able to provide for my family, I believe God has blessed me, and has shown me there are things to look forward to."

"My overall experience at the **KCEOC Community Action Part**nership KY Career Center Jobsight was great. One of the best parts of the program was working with change my life, and is a great person. I would call her about things I was worried about and she would always be positive and helpful. She always believed in me even when I didn't believe in myself. I trust I am where I am today because of her help." Glenn revealed a hidden learning disability, he was able to graduate high school yet was unable to read or spell. He credits his wife for helping him overcome this disability, but it added extra anxiety about attending college. But perhaps the best part was that the program changed my ways of thinking and gave me a positive perspective. If people would take advantage of what the community has to offer them instead of giving up they could see a positive future and be self-sufficient too."

**Looking at his future Glenn says** he sees himself earning Bachelor's degree. He wants to pursue teaching and advance in the respiratory therapy field. He wants inspire others to show them they can achieve whatever they put their minds to. "I had a second chance, and I want to help others get one too."



Glenn has since became a hometown hero, working the frontlines and caring for COVID-19 Patients.





# **KY Career Center Jobsight Programs**

Our Kentucky Career Center Jobsight helps people find jobs and upgrade their skills to qualify for better jobs. Jobsight services adults looking for work, workers of any age who have been dislocated from their jobs through closings or layoffs, and economically disadvantaged young people who need help to get education, training, and a good start into the working world. KCEOC is the area job sight link for employees looking for employment and employers looking for qualified employees.

#### **Programs Include:**

#### **Opportunity Youth Program**

Serves 18 - 24 year olds who are not attending school and have a past criminal record or other barrier to employment. Participants are assisted with career planning, obtaining employment and/or training opportunities. Must meet federal guidelines. Paid services based on funding available. Contact WIOA office to help determine eligibility.

#### Dislocated Worker Program

Serves those who are age 18 or older who have been laid off and are eligible to receive Unemployment Insurance benefits. Participants are assisted with career planning, employment services, job searching, tuition assistance for training, and supportive services (supplies/uniforms required for training or employment). Must meet federal guidelines. Paid services based on funding available. Contact WIOA office to help determine eligibility.

#### **Mining Program**

Serves those who are age 18 or older who have been laid off from a Mining position and are eligible to receive Unemployment Insurance benefits. Participants are assisted with career planning, employment services, job searching, tuition assistance for training, and supportive services (supplies/uniforms required for training or employment). Must meet federal guidelines. Paid services based on funding available. Contact WIOA office to help determine eligibility.

#### **Adult Program**

Serves those who are age 18 or older who are unemployed or are considered underemployed based on their wages. Participants are assisted with career planning, employment services, job searching, tuition assistance for training, and supportive services (supplies/uniforms required for training or employment). Must meet federal guidelines. Paid services based on funding available. Contact WIOA office to help determine eligibility.

#### **Employer Services**

Employer services is designed to assist area employers find and prepare workers to fit their needs. Services including on-the-job training, work experience, and job fairs. Our goal is to match up employers with qualified skilled workers. Serves those who are age 18 or older who are unemployed or are considered underemployed based on their wages.

# THE 2020 CENSUS

- · Conducted every 10 years by the U.S. government
- Counts every person living in the USA
- Includes 10 questions, takes 10 minutes to complete
  - Name, relationship to householder, phone number, size of household, age, sex, race, Hispanic, if temporary living situation
  - Census forms are available online in 59 languages. over the phone in 13 languages, or on paper in English or Spanish

CENSUS DAY is April 1, 2020 but you can fill out the Census anytime between March 12 and July 24 via one of these methods:









ON PAPER

IN PERSON

Households will receive a letter in the mail beginning in March with instructions to complete the Census.





#### CENSUS DATA DETERMINES:

- Your state's number of seats in the House of Representatives
- Legislative districts
- Federal funding for local programs
  - LIHEAP
  - **Head Start**
  - Section 8 vouchers

  - **WIOA** activities
  - Programs for the Aging, Title III
  - and more!

Federal funding to state programs is about \$2,000 PER YEAR FOR 10 YEARS per person counted in the Census.

Missing just 100 people in our area could mean we miss out on \$200,000 per year, or \$20 MILLION over 10 years!

## THE CENSUS IS SAFE

Records are kept confidential by law for 72 years. The U.S. Census Bureau is prohibited from sharing respondents' personal details with other government agencies. Census Bureau employees swear a lifetime oath to protect respondent information.

# **Head Start Closure Update**



# **Scholarship Opportunity**

KCEOC Community Action Partnership is currently taking applications for the James J. Davenport Community Services Block Grant (CSBG) Education Scholarship. Interested applicants must complete all application requirements, including being a current Knox County resident, having a minimum 2.5 GPA, and meeting CSBG income guidelines.

Education made possible through the scholarships include either general education to achieve short-term training (2 years or less) in growth occupation skills, or general post-secondary education.
