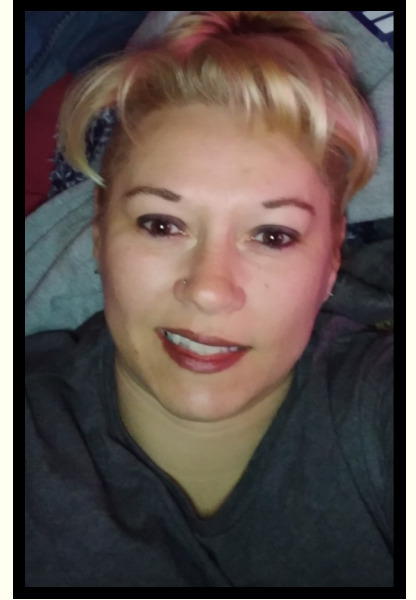

## Meet Robin: A Rapid Rehousing Success Story



Robin, grew in up in Pineville KY, with her mom, (step) dad, and her two brothers, but sadly she lost every member of her family in rapid succession, she lost her mom to a brain aneurysm, her dad to heart/lung disease, a brother to heart attack, and her other brother in an ATV accident. “My life was turned upside down, I felt like I was alone in the world and sadness overtook my whole life, losing your family is an unbearable pain, so I began to self-medicate and this lead me down at bad path”, said Robin. I was abusing drugs and getting into trouble just have something to distract me from the pain I was feeling, I pushed away my remaining family, and still my situation got worse when I became homeless after leaving an abusive marriage. I was staying anywhere I could, sleeping in abandoned houses just to stay out of the cold. Soon I ended up getting arrested, and sent to drug court, my arresting officer Assistant Chief of Police Jake Knuckles was also on my drug court team, he said he wasn’t going to see another person in his community lost to the madness of the drug world, and then he told me something I had not heard in a very long time, that there were people that would help me, that I was not alone, and that I had the power to change my life, he referred me to KCEOC Community Action Partnership and I became a client of the rapid rehousing program (RRH). It was there I met my wonderful case manager Bonita, who not only helped me find stable housing, she let me know that I was not helpless or hopeless, even though I felt like I was, she made me feel worthy of a new start in life, and when you feel better about yourself you make better choices. I decided that I needed to enroll in a rehab program to deal with the root of my problems that led to addiction to avoid ever going down that road again, and I can now proudly say I’m clean and sober, and living independently in an apartment of my own. I don’t think I could ever thank KCEOC, Bonita, or Officer Knuckles enough- they literally saved my life!

KCEOC Community Action Partnership Inc. Rapid Re-Housing (RRH) program is designed to help homeless individuals and families obtain and secure permanent housing. RRH participation is an inclusive program not limited to employment status, income, criminal record or sobriety. RRH offers individualized case management tailored to meet the unique needs of each client(s), and includes lessons to retain permanent by teaching ways to increase income, money management skills, and connection with community resources that address mental health, food insecurity, and job placement programs, and/or assistance transitioning to the Section 8 program. The goal of the Rapid Re-Housing program is to elevate homelessness by helping individuals overcome barriers and become permanently and stably housed.

Applications are available electronically, Walk-ins and appointments are available with curbside assistance

**All applicants will be required to supply the following documentation at time of application:**

- Proof of Social Security Number or Permanent Residence card (Green Card) for each member of the household.
- Proof of all household's (all members) income from the preceding month.
- The account number and name on the account for main heating fuel sources and electric bill.
- Most current heating bill, statement from your landlord if heating expenses are included in your rent, or a statement from utility company if you participate in a Pre-Pay Electric Program.
- Applicants requesting assistance for natural gas or electric must bring a disconnect/past due notice (example: arrearage payment plan, past due notice, termination notice, or final notice). If your rent includes heat you must bring a copy of your lease and eviction notice. Applicants who participate in a Pre-Pay Electric Program must bring a statement from the utility company that shows they have 10 days or less of pre-paid electric service.

**1 in 5 AMERICANS**  
are unaware that they qualify for the Earned Income Tax Credit



Each year, millions of dollars are lost by hard-working families in the Bluegrass who do not file for their Earned Income Tax Credit (EITC) during tax time. That money is lost to the families and the local economy. The IRS estimates that approximately 20 to 25 % of people eligible for the credit do not claim it because they don't know they are eligible, know how to claim it, or do not know where to go for assistance. KCEOC's goal is to make eligible households aware of the credit and help them claim it without having to pay for tax preparation and filing services.

KCEOC Community Action Partnership is part of a coalition, led by United Way of the Bluegrass and the IRS to provide free tax preparation to low-income families, raise awareness about the Earned Income Tax Credit and help families build assets.

Thanks to the work of hundreds of volunteer tax preparers, families are able to save their much needed money while strengthening our overall economy.

The free tax preparation provided by KCEOC CAP and its volunteer tax preparers offer immediate savings to Southeastern Kentuckians.

In response to the COVID-19 emergency, KCEOC Community Action Partnership (CAP) participating in the tax preparation for the 2020 tax season. KCEOC CAP will offer curbside pickup and tax preparation.

The Volunteer Income Tax Assistance (VITA) Program provides free income tax return preparation to hard working taxpayers earning up to \$64,000 annually. VITA helps working families take advantage of all of the tax credits they are eligible for including the Earned Income Tax Credit (EITC), Child Tax Credit (CTC), and education credits. Volunteers from the community help prepare basic, current year tax returns for eligible taxpayers free of charge.

**Information required for tax preparation : Please have your tax documentation information ready for faster processing.**

**What to Bring:**

- \*For married filing joint, both spouses must be present
- \*Proof of identification for yourself and/or your spouse
- \*Social Security cards or Individual Taxpayer Identification Notice (ITIN) for you, your spouse, and/or dependents
- \*Proof of foreign status if applying for ITIN
- \*Birth dates for you, your spouse, and/or dependents on the return
- \*All forms: W-2 and 1099
- \*Information for "other" income
- \*Information for all deductions and credits
- \*Daycare: Providers name, Providers Tax ID number, and total amount paid
- \*Proof of account for direct deposit
- \*Copy of last year's return
- \*For Prior Year Returns – copies of income transcripts from IRS (and state, if applicable)

**KCEOC Community Action Partnership now has funding available for Homeless Prevention Services. Households must live in Bell, Harlan, Knox, or Whitley Co. Households must also be below 50% of area median income, & must not have sufficient resources or support networks immediately available to prevent them from moving to an emergency shelter or other location.**

**Applicants must meet one of the following “At-Risk” Factors:**

- Has moved because of economic reasons two or more times during the 60 days immediately preceding the application for homelessness prevention assistance;
- Is living in the home of another because of economic hardship;
- Has been notified in writing that their right to occupy their current housing or living situation will be terminated within 21 days after the date of application for assistance;
- Lives in a hotel or motel and the cost of the hotel or motel stay is not paid by charitable organizations or by federal, State, or local government programs for low-income individuals;
- Lives in a single-room occupancy or efficiency apartment unit in which there reside more than two persons or lives in a larger housing unit in which there reside more than 1.5 people per room, as defined by the U.S. Census Bureau;
- Is exiting a publicly funded institution, or system of care (such as health-care facility, mental health care facility, foster care or other youth facility, or correction program or institution); or
- Otherwise lives in housing that has characteristics associated with instability and an increased risk of homelessness, as identified in the recipient’s approved consolidated plan
